The final drawing and prize distribution, as discussed below will occur in January 2019 to allow enrollment throughout the Promotion Period. CSU's computer is the official time-keeping device for the Promotion.
2. **Promotion Scope:** CSU will randomly select one (1) winning Participant (as defined below) per quarter and each quarterly winning Participant will receive one (1) Prize, as stated below. Drawings will be held during the first weeks of April, July and October 2018, and the first week of January 2019 to select the winning Participants.
